When: Sunday, April 4th; racing starts at 10:00am Check-in starts at 9:00am. Riders go off at one-minute intervals.

Where: Maple Park, IL (Rt.38 and Rt.47) See Directions to race site below.

Registration: Pre-Race registration post-marked by March 26th or received at ABD event at the Subaru Bike Show on Navy Pier will be accepted. On-site registration opens the day of the race at 8:30am. Race entry is limited to 200 competitors.

Awards: Medals awarded to top competitors in ABR and Citizen categories. \$50/\$30/\$20 for fastest men and women. Recumbents eligible only for medals.

Directions:

From the North (Rockford)

Go south on I-39 Drive 21.0 miles to junction with I-88 (exit 97) Go east on I-88. Drive 15.6 miles to exit #65. Go north on Peace Rd. Drive 1.5 miles. Turn right on East Lincoln Highway (Illinois Route 38). Drive 6.5 miles. Turn left on East County Line Road Drive 0.6 miles Turn right on Main Street.

From the Western Suburbs (Wheaton)

Go west on IL-38 14.2 miles from the intersection of Randall and IL-38 in St. Charles, to East County Line Rd. Turn right on East County Line Road. Drive 0.6 Turn right on Main Street.

From Chicago

Go west on I-88 to Illinois Route 47. Turn left (North) on Illinois Route 47. Drive 0.2 miles (~ 3 blocks) Turn right on Finley Road Drive 0.1 miles (~ 1 block) Turn right on Seavey Road. Drive 2.1 miles. Turn right on Harter Road. Drive 6.4 miles. Turn right on East County Line Road. Drive 3.0 miles. Turn right on Main Street
