**DISTANCE:** 60 Kilometers.

CLASSES: Open (1~4) Masters 30+ Masters 50+ Masters 70+ Women 40+ Women 60+

Junior Open Masters 40+ Masters 60+ Women Open Women 50+

(Riders on age group team must be at least the minimum age specified for that age group.)
(Teams may consist of any quantity of Men or Women, except Women classes are for Women only)

**AWARDS:** 1<sup>ST</sup> Place: Four World Championship Jerseys and World Championship Awards to each team 2<sup>nd</sup> through 5<sup>th</sup> Place for Open, Masters 30+, Masters 40+, Masters 50+ and Masters 60+ are Four Awards per team.

2<sup>nd</sup> through 3<sup>rd</sup> Place for Junior Open, Masters 70+, Women Open, Women 40+, Women 50+ and Women 60+ are Four Awards per team.

Fastest Team cash prize: \$200, 2<sup>nd</sup> \$120, 3<sup>rd</sup> \$80.

Fastest Women Team cash prize: \$200, 2<sup>nd</sup> \$120, 3<sup>rd</sup> \$80.

## ALL RIDERS ON A TEAM>>MUST WEAR IDENTICAL JERSEYS<<

Bicycles must be no more than 2 meters long and 75 cm wide. (no recumbents or tandems).

**REGISTRATION OPENS:** 8am **MOTELS:** Super 8 815-251-2223; Motel 6 815-224-2786

FIRST TEAM OFF: 9am and at two minute intervals thereafter. Support vehicles are allowed. Timing is done on the front of the front wheel of the third bicycle in on a team.

REGISTERING AND ENTRY FEE: \$100 per Team. Make checks payable to 'American Bicycle Racing' and send to ABR, P.O. Box 487, Tinley Park, IL 60477-0487. If you are not a member of ABR, a One Day Membership will be issued to you on a complimentary basis. Entries must be submitted with an ABR Accident Waiver and Release of Liability form for each team member. This form is available on the ABR Website www.ambikerace.com. To speed registration only your Team Leader should pick up your numbers or register your team on race day. There is no Late Registration Fee. Starting times are assigned in the order that entries are received. A "Received Entry" is getting all of your paperwork and fees into ABR" hands and not an email or phone call expressing your intent to enter.

**COURSE:** Event will be run in LaSalle County, Illinois on mostly flat Illinois farmland roads which are lightly traveled. Wind can be a factor. A map of the course will be provided in your race package. Start and Finish on N.33<sup>rd</sup> just east of Waltham School.

<u>**DIRECTIONS TO COURSE:**</u> Take Interstate 80 to Utica exit 81. North approximately 3 miles to County Highway 33. Turn right on Highway 33 and go 1 mile to registration at Waltham District School.

**NOTE:** Parking available at Waltham School and Waltham Township Office Building and on road shoulder just east of registration, on 9<sup>th</sup>, south of County Highway 33.
