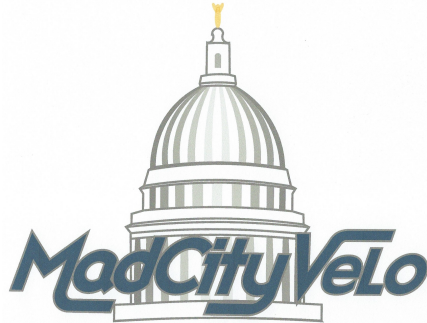


The Badfish Creek 20K /40K Time Trial

18th Annual MadCity Velo Time Trial, Saturday July 29, 2023



DESCRIPTION: The Badfish Creek Wildlife Area forms the center of this one or two lap time trial. Only three right turns per lap. Start at Center Rd. & Old Stone Rd. Go E on Old Stone to Danks, go S on Danks to Old Stage, go W on Old Stage to Old Stone, go E on Old Stone to finish at Center for 20K. Repeat loop for 40K. First two roads make-up smooth, long straightaways. Remainder of course is rolling terrain.

START: Slightly south of the intersection of Center Rd. & Old Stone Rd.

FINISH: Slightly west of the intersection of Center Rd. & Old Stone Rd.

AWARDS: - ABR medals five (5) deep; T.W.O.(Triathlete/WiSport/Open) medals three (3) deep all categories.

- WiSport Points awarded toward 2023 series.

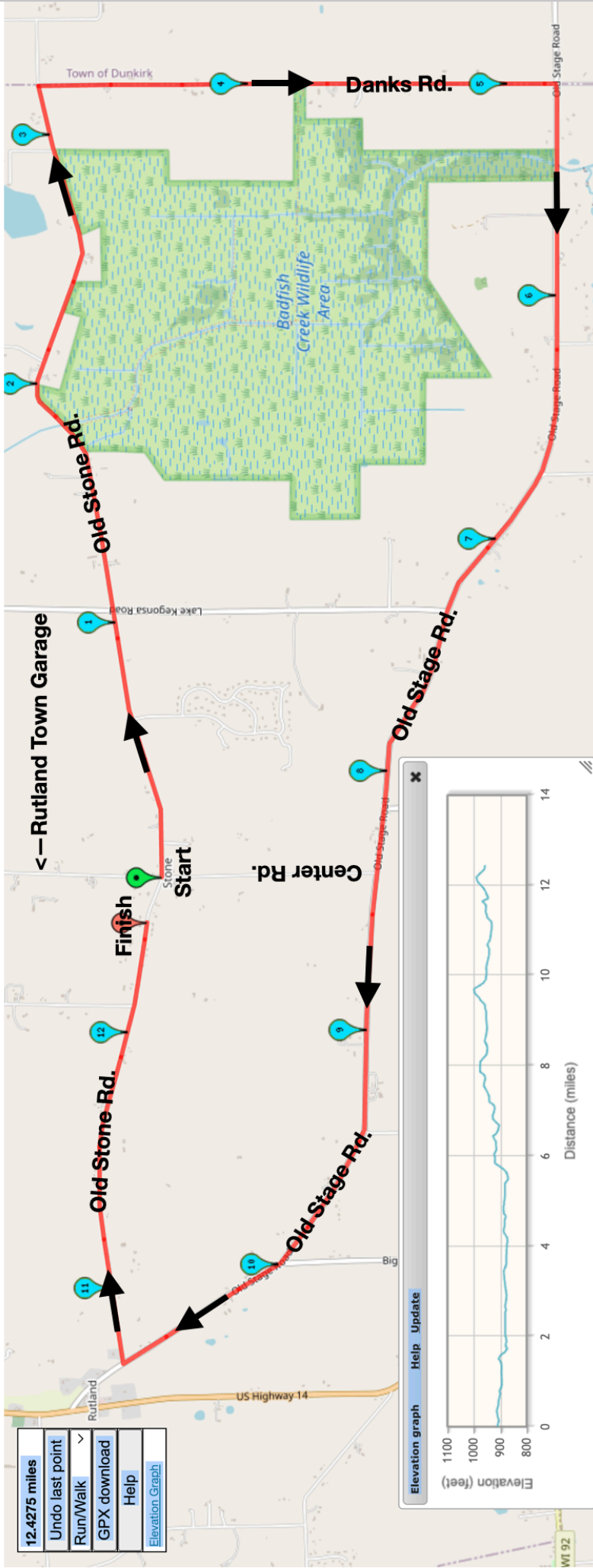
